- 4. Peer Review
 - a. Have a partner read your draft and make suggestions.

- 1. Finish Rough Draft
 - a. Use your outline to help you structure your essay.
- 2. Proof Read & Edit
 - a. Read your draft and make any changes needed.
- 3. Peer Review
 - a. You must have at least 1 classmate read your rough draft and make suggestions.
 - b. They must leave feedback (in pen) on your rough draft.


- 1. Finish Outline

- 4. Peer Review

5. Final Draft

- a. Have a partner read your draft and make suggestions.
- a. On a separate piece of paper (DOUBLE SPACED)

Final Draft Day

- 1. Final Draft
 - a. Double space! Don't add extra space for new paragraphs, just indent.
- 2. Make sure everything in your DBQ packet is complete.
- 3. Staple your packet in the following order:
 - a. Final Draft
 - b. Rough Draft
 - c. DBQ Packet
- 4. Make sure your name is on EVERYTHING!
- 5. When finished, proofread your work.



DBQ Packet Rubric
